## DSSO Meeting Schedule Changes

*DSSO made the following changes at the December meeting as a result of your responses to the survey.*

The new schedule is on a three month trail to make sure that this will work. That was approved by the members at the December meeting.

First, we moved the meeting day to Saturday from Sunday.

Second, we are keeping the 4 p.m. start time.

Third, there will be a dinner potluck after the meeting.

Fourth, Game Night will be after the dinner potluck.

### **Date and schedule change**

From your responses to the survey, we changed the date from Sunday to Saturday. Note that this is the second Saturday - January 12.

We are keeping the 4 p.m. start time because the members at the December meeting voted to fit the dinner

potluck and the Game Night in the schedule.

What this means is that we are planning to have the meeting run for maybe two hours. Then have the dinner potluck for maybe an hour. After that, the Game Night can start at 7 p.m. or earlier and end around 10 p.m.

### **Rules for dinner potluck**

The dinner potluck should have real foods and real dishes, not junk foods like chips, crackers and candy. The flyer will explain more. We will enforce this rule.

Desserts (cookies and cakes) are allowed as long as you bring a real dish.

Each dish should be enough for 5 or so persons.

We will provide extension cords for your crockpots, slow cookers and warming trays.

Because this involves foods, the meeting will be in the Lions Center's Dining Room.
