Bill Drobkiewicz, DSSO Newsletter Editor, and other deaf and hard of hearing people attended the above shows through the weekend.

Fences, *A Midsummer Night's Dream* and *Welcome Home, Jenny Sutter* were interpreted for the deaf while *The Clay Cart* had open captions. The 2008 season has a new signing coach, Bill Seago. That improved interpreting so much - it became easier to see who was saying what; there were adjustments to signing and expressions and lighting (on the interpreters) became better focused.

All the deaf attendees had a great time watching these shows and getting a lot more from the shows. OSF would love to have a lot more deaf attendees because they want to make live theater accessible and enjoyable for the deaf. The Clay Cart is the first show of the season to feature open captions. This will benefit hard of hearing people and other deaf persons who do not know sign language.

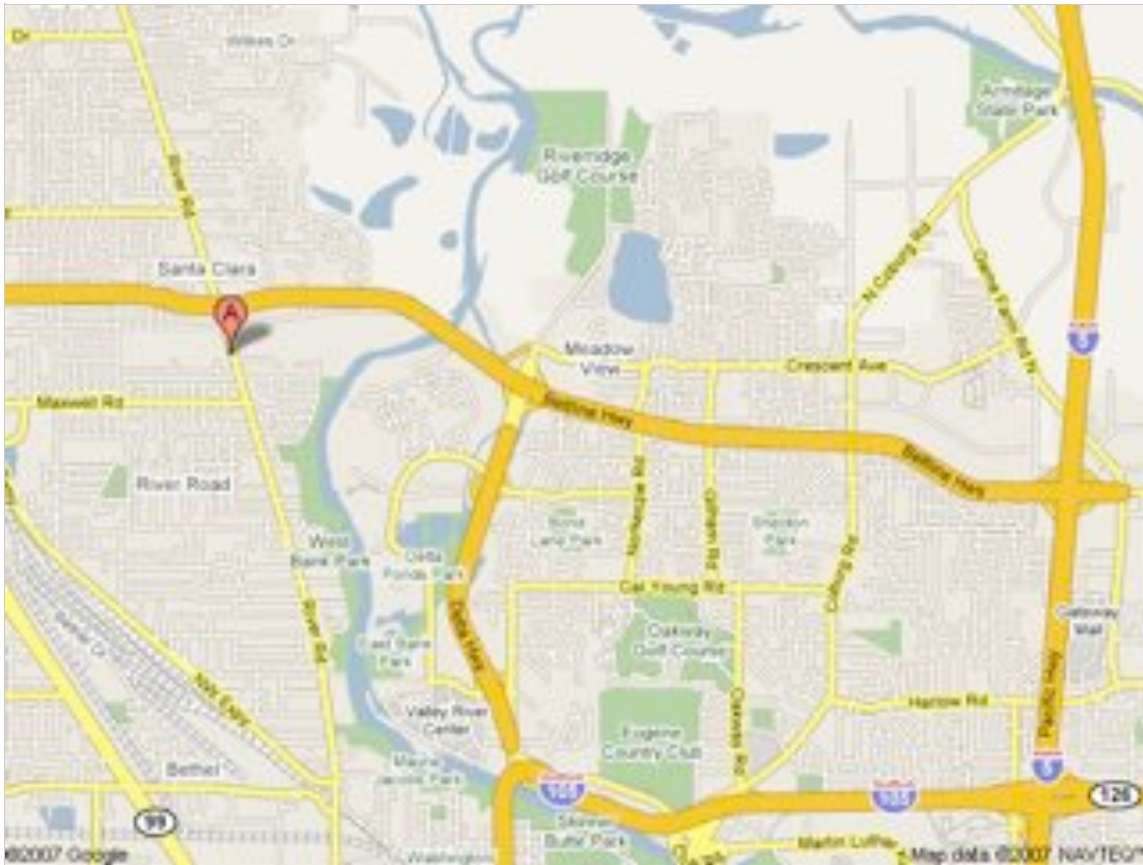
